## State budget shortfall = Medicaid rate cuts

Cuts to Medicaid provider reimbursement rates, including those for dentistry, are now being planned by the Department of Public Health and Human Services as a result of falling state revenue. The amount of the decrease will be at least 1 percent and could be as much as 5.3 percent.

A bill passed by the Montana Legislature earlier this year mandates a reduction in state expenditures when revenues fall below the forecast included in the budget. When the revenue shortfall was announced, it triggered \$97 million in expense reductions, including \$14 million from DPHHS. The Legislature stipulated that Medicaid provider rates be cut by 1.0 percent. Gov. Bullock also then directed DPHHS to further decrease Medicaid rates by 2.47 percent (this could grow to a 5.3 percent total decrease in rates, depending on when it may be implemented during the current fiscal year).

MDA launched a grassroots campaign in July to oppose the cuts, as did other did many Medicaid providers. MDA

members have contacted Gov. Bullock asking that he not reduce rates. The Children, Families, and Human Services Interim Committee (CFHSIC) has also expressed its concern and will opposing rate consider the reduction at the committee's September 11 meeting.

"Of all options available to further decrease DPHHS costs, reducing Medicaid rates under-

mines your commitment to the health of children, the disabled, elderly and low-income Montanans," MDA president Dr. Kevin Rencher said in a letter to Gov. Steve Bullock.

"The proposed action is poor public policy. Please do not further reduce reimbursement for care of Medicaid patients."

Dr. Rencher further noted that Montana dental Medicaid reimbursement is approximately 53 percent of the usual fee charged by dentists.

"Most dental offices operate on an overhead of about 65 percent, so Medicaid doesn't even cover the cost of care and provides no personal reimbursement to the dentist. Simply stated, dentists are giving away treatment and are personally subsidizing care for Medicaid patients."

MDA's grassroots lobbying campaign is continuing. Dentists can help by contacting legislators and asking them




## Making Medicaid work for your practice

The Symposium will also cover advocacy and policy opportunities to support a sound and stable Medicaid program. MDA's bill ensuring a fair and reasonable Medicaid audit process was enacted earlier this year. SB 82, sponsored by Sen. Albert Olszewski (R-Kalispell), establishes audit standards that include limits on record requests and audit look-back period and allows Medicaid providers to contest audit findings though peer review.

## Checking Medicaid patient eligibility

Jan Paulsen, DPHHS Medicaid dental program officer has provided this information on Medicaid eligibility.

When checking eligibility status on the MT Access to Health Web Portal, the dental treatment limit (for adults and HMK/CHIP kids) will now display the remaining reimbursement balance. If the member is Aged, Blind or Disabled, it will display a message stating, "Currently this member is exempt from the dental limit." If the person is under the care of the Department of Corrections, under the client demographic information, the Status field will say Inactive.

There may be other claims pending adjudication by the system which may be paid before your claim is submitted thereby reducing the available remaining balance from the

amount reported on the web portal. Limits should be verified on each visit for the current date of service.

> Private pay agreements should include a statement recognizing unpaid claims may use the

remaining balance and the member will then be responsible for payment of services provided. Also be advised that the Plan Coverage Description is still wrongly being referred to as Full Coverage, everyone now has Standard Coverage. Medicaid kids, HMK Plus, under age 21 are not subject to a dollar limit.

## Dental Board considering hygienist prescribing, specialty advertising rules

Rulemaking and litigation are front and center this summer for the Montana Board of Dentistry. The board has proposed new rules to implement prescribing authority for dental hygienists, as included in a bill passed in the 2017 Legislature. The Board is also considering amendments to its rules on specialty recognition and advertising, as a result of potential litigation. And the Federal Trade Commission is stepping into the lawsuit filed by the Denturists Association of Montana against the board for its rules that prohibit denturists from placing dentures over implants.

Senate Bill 120 allows dental hygienists to prescribe topical anesthetics, fluoride agents, and non-systemic microbials. The board's rules will specify which agents, ingredients and at what percentages hygienists may prescribe.

The bill also now permits dentists to delegate administration of local anesthesia to hygienists under general supervision.

The Board of Dentistry's rules for recognition of specialties, announcement of specialties and advertising

have long been based on ADA's Code of Ethics. Only those specialties recognized by the ADA are recognized by the Montana board. Other state dental boards have also followed the ADA code. Specialties organizations not recognized by the ADA have successfully sued dental boards in several states, including Texas and Ohio, alleging restraint of trade and restraint of commercial speech. These cases have been upheld on appeal by those boards and plaintiffs in those cases may seek to overturn Montana's rules by litigation. The ADA is taking steps to review its specialty recognition process and recommendations are anticipated presented to the 2017 ADA House of Delegates.

In May, further action on denturists lawsuit was stayed pending the outcome of an FTC investigation into "the board's policy, rules, and actions related to licensed denturists practicing in Montana."

## Healthcare transparency focus of 2017 Legislature

Healthcare "transparency" became a major focus of legislation in the 2017 session. Legislators sought to impose more regulation over providers to create greater awareness by patients about their choices and the cost of treatment. Senate Bill 362, which integrated cost and quality of care data, was passed by the Legislature, but vetoed by Gov. Bullock. MDA opposed the bill initially, but worked with other provider groups to remove small practices from the bill.

A legislative resolution, HJR 20 was approved by the legislature and sets up a study of transparency in health care pricing. The study was the top-ranked study in a post-session poll asking legislators to prioritize the 20 study resolutions approved in 2017.

The Children, Families, Human Services Interim Committee has created the Healthcare Price Transparency Subcommittee and directed it to look into these items:

- factors influencing the cost of health care services, including differences attributable to different delivery system models;
- · efforts undertaken in other states and by organizations

- within Montana to make health care cost information more widely available to consumers;
- ways to improve consumer understanding of the different factors affecting the costs that are charged and the costs they must pay;
- ways to encourage consumers to make informed health care decisions;
- existing price transparency tools and health quality measures:
- ways to ensure that price transparency efforts give consumers information about both costs and quality of services; and
- the role of the state in improving health care price transparency.



### What you don't know can cost you!

### Jennifer L Nieto, President RJ Card Processing, d/b/a Best Card

The credit card processing industry is complicated and contracts can be difficult to read and decipher. Here is a list of pitfalls we often see in the industry and what you should pay attention to:

#### **Setup fees**

Some processors charge you a fee to setup your business under their programs.

Best Card has no setup fee.

#### **Early termination fees**

It is very common to have an early termination fee (often ranging from \$250-750) if you leave a processor before the end of your contract. Some companies supplement these fees with lost profitability clauses (you pay their profit margin for the life of contract) and mandatory minimums (e.g. \$25 per month for all remaining months). Most processors have a three year contract so it can cost thousands to leave. Always make sure to get this information in writing.

▶ Best Card only has a \$25 early termination fee. After three years, the close fee drops to \$0. We have no lost profitability clauses or mandatory minimums.

#### **Auto-renewal of contracts**

Most processors now automatically renew contracts when they expire, locking merchants into a new contract, and often also renewing the above early termination fee.

▶ Best Card does not auto-renew our contracts. After the initial three-year contract is up, the merchant is on a month-to-month agreement.

#### **Bait and Switch**

Some processors will prepare a cost analysis with slightly better rates than you presently pay and then subsequently increase rates. Any processor can increase rates via a thirty-day notice and if you agree to the aforementioned termination fees, it can be very costly to either stay with or leave them.

▶ Best Card has only had two rate increases on our tiered program in 10+ years. Total fees ÷ total \$ amount processed averages 2.1% for our merchants (it costs \$2.10 to process \$100 with Best Card).

#### Leases

Beware of leases on equipment – they are expensive, non-cancellable, and merchants often end up paying much more than the equipment actually costs. Ex: 48 months x \$30 = \$1,440 and a buyout of \$100 at the end of the lease.

Best Card does not lease equipment. We sell terminals and swipers at cost and often offer great deals like \$100 off the price of new EMV "chip reading" equipment so you can own for as little as \$169.

#### **PCI** compliance

Payment Card Industry (PCI) is an annual online test regarding credit card information protection. Processors almost always outsource PCI testing to third parties, and the annual cost is normally between \$70-120. Non-compliance fees often range from \$18-40 per month.

▶ Best Card charges \$36 annually for PCI compliance. Merchants have 90 days to become PCI compliant with a new processor, and Best Card will repeatedly contact offices via phone, email, and fax to help them pass the test and avoid an \$18.95 monthly noncompliance fee.

In 1997, the Montana Dental Association partnered with Dental Lifeline Network • Montana in developing a Donated Dental Services (DDS) program to help people with disabilities or who are elderly or medically fragile and had no other access to dental care. The Montana DDS program is similar to programs developed by Dental Lifeline Network in 41 other states. DLN projects that DDS volunteers will provide almost \$25 million in donated treatment in fiscal year 2016-2017. Since inception, Montana dentists and labs have donated over \$4.3 million worth of comprehensive treatment for 1,285 vulnerable people.

The DDS program restores the oral health and often transforms the lives of the patients we serve, like 50-old Mr. K. who lives alone in Helena. He has developmental

disabilities and cannot read or write; and suffers from attention deficit disorder, hypertension and depression. Mr. K. was missing all but three teeth, but sadly, he could not afford dentures. Despite his disabilities, Mr. K. works the night shift as a house person at a local hotel. He earns just enough to pay for very basic necessities and cannot even afford the medication he needs. He was able to get his remaining teeth extracted at a local health clinic, but the clinic did not provide him dentures and he couldn't afford them.



Fortunately he was referred to the DDS program and Mr. K. was linked with two generous volunteers who agreed to help: a general dentist and a lab. **Thanks to this team, Mr. K. received \$4,552 in donated care that restored his oral health and gave him a reason to smile!** He shared his appreciation for this amazing gift.

"Your help made a big difference in my life. I don't have to hide my mouth anymore. My teeth eat really good, and people tell me my new teeth look real. I really, really appreciate all your help."




